### **CALCULATION OF POST EMPLOYEE BENEFITS IN TERMS OF GRAP 25 AS AT 30 JUNE 2020**

#### **TERMS OF REFERENCE**

##### **1. PURPOSE**

The Municipality wishes to invite a suitably qualified service provider to provide a calculation for provision of Post Employee Benefits In Terms of GRAP 25 as at 30 June 2020.

##### **2. BACKGROUND**

In terms of Chapter 12 of the Municipal Finance Management Act, Act 56 of 2003-, Section 122 of the act requires that;

- (1) Every Municipality and or municipal entity must for each financial year prepare annual financial statements (AFS) which: -
  - (a) Fairly presents the state of affairs of the Municipality or entity, its performance against its budget ,its management of revenue, expenditure, assets and liabilities, its business activities ,its financial results and its financial position as at end of the financial year, and
  - (b) Disclose the information required in terms of section 123.124.125 as well as 126.
  
- (2) A Municipality which has sole control of a municipality ,or which has effective control with the meaning of the Municipal Systems Act of municipal Act of a municipality which is a private company, must in addition to complying with subsection(1),prepare consolidated annual financial statement.

- (3) Both annual financial statements and consolidated annual financial statements must be prepared in accordance with the generally recognised accounting practice (GRAP) prescribed in terms of section 91(1) (b) of the Public Finance Management Act.

### **GRAP 19 Provisions**

#### **Para.21 State that an entity shall recognise a provision when**

- a) There is present obligation (legal or constructive) as a result of past event
- b) It probable that an outflow of resources embodying economic benefits or service potential will be required to settle the obligation; and
- c) A reliable estimate can be made of the amount of the obligation

#### **Para. 52 states that where the effect of time value of money is material, the amount of provision shall be the present value of expenditure expected to be required to settle the obligation**

### 1.1. Introduction

The purpose of this evaluation is to enable the Municipality to provide appropriate disclosure in the Annual Financial Statements

### 1.2. Scope of Valuation

The effective date of the valuation is the 30 June 2020

The valuation considers all employees, retirees and their dependants whose participation in the health care arrangements entitles them to a post-employment medical aid subsidy. The post-employment health care liability is not a funded arrangement that is not a separate asset that has been set aside to meet this liability.

There are approximately **three hundred and forty three (500)** employees and the number excludes **sixty four (40) Councillors**

**The number of retirees and their dependents is approximately twenty (20) and also requested is the actuarial valuation of its liability in respect of Long Service Awards to employees. The effective date of the evaluation is 30 June 2020.**

The valuation considers all employees eligible for Long Service Awards "LSA" and post-employment medical aid subsidy. The Municipality will provide the data for this valuation.
